**ORDER APPROVING FINAL APPLICATION
FOR APPROVAL OF FEES AND EXPENSES OF
BUSH ROSS, P.A. FOR THE PERIOD FROM FEBRUARY 1, 2021
TO THE CLOSING OF CASE AND FOR AUTHORIZATION OF PAYMENT**

This case came before the Court for hearing on May 26, 2021 at 11:15 a.m. for consideration of the Final Application for Approval of Fees and Expenses of Bush Ross, P.A. for the period from February 1, 2021 to the closing of the case (the “**Motion**”). The Court, having reviewed the Motion, and having been otherwise advised in the premises, finds that the Motion should be granted. Accordingly, it is,

ORDERED AND ADJUDGED:

1. The Motion is **GRANTED**.
2. The Court finds that the total amount of the fees (\$8,892.48) and costs (\$107.52) expended by Bush Ross, P.A. (“**Bush Ross**”) for services provided to the Receiver for the period from February 1, 2021 to the closing of the case in the amount of \$9,000.00, (the “**Fee Period**”) is ordinary and reasonable for the services rendered.
3. The services rendered by Bush Ross during the Fee Period were beneficial to and in the best interests of the Receivership estate. Accordingly, in accordance with the Order

Appointing Receiver and the Court's prior orders concerning payment of the fees of the professionals retained by the Receiver, the Receiver is authorized to pay Bush Ross **\$9,000.00** representing the full amount sought in the Motion for fees and costs during the Fee Period.
