**ORDER APPROVING APPLICATION TO EMPLOY
BUSH ROSS, P.A. AS RECEIVER'S COUNSEL**

This case is before the Court for consideration of the Receiver, Michael E. Moeker's ("Receiver") Application to Employ Bush Ross, P.A. ("**Bush Ross**") as Receiver's Counsel (the "**Application**") pursuant to the Amended Order Appointing Receiver entered April 14, 2010 (the "**Order**"). Upon consideration of the Application and the Order, and it appearing that the Receiver's retention of Bush Ross as its general counsel is in the best interest of the parties and the public in interest, it is **ORDERED** that:

1. The Receiver is authorized to retain Bush Ross as its general counsel in this case, with such employment being effective *nunc pro tunc* to April 2, 2010, the date of the Receiver's selection of Bush Ross to serve in this capacity.

3. Bush Ross shall be compensated in accordance with the Order, and such procedures as may be fixed by order of this Court.

4. This Court shall retain jurisdiction over any and all issues arising from or related to the implementation and interpretation of this Order.
