ORDER APPROVING DISPOSITION OF 2010 PORSCHE 911 TURBO CABRIOLET

This case came before the Court for hearing on July 13, 2010 upon the Receiver, Michael E. Moeker's ("Receiver") Motion for Approval of Disposition of 2010 Porsche 911 Turbo Cabriolet (the "Motion"). The Court having heard argument and being otherwise fully advised in the premises, the Court finds that the sale of the Porsche is in the best interest of the Receivership Estate and is necessary for the adequate protection of the rights of the parties. The Court further finds on the evidence presented that that sale of the Porsche that results in a net recovery to the Receivership Estate of no less than \$140,000 is reasonable. Accordingly, it is ORDERED and ADJUDGED that:


1. The Motion is GRANTED. it is further ORDERED and ADJUDGED that,
2. The Receiver is authorized sell the 2010 Porsche 911 Turbo Cabriolet, VIN No. WP0CD2A92AS773195 under terms that result in a net recovery to the Receivership Estate of no less than \$140,000.
3. Princeton Porsche, 3333 Rout 1, South Lawrenceville, New Jersey, may sell the Porsche, to an independent purchaser under terms that result in the payment to the Receiver in the

amount of no less than \$140,000, inclusive of any refunds for the payment of state sales tax and fees.

4. Princeton Porsche shall not receive any commission, fee, or other compensation resulting from the sale of the Porsche.
