PLAINTIFF'S MOTION FOR ORDER DIRECTING THE CLERK OF COURT TO FILE CERTAIN DOCUMENTS UNDER SEAL

Plaintiff, Office of the Attorney General, Department of Legal Affairs, State of Florida, by and through its undersigned attorneys, hereby files this Motion for Order Directing the Clerk of Court to File Certain Documents under Seal, and states as follows:

- 1. Plaintiff filed the instant lawsuit against Defendants Botfly L.L.C. ("Botfly"), David R. Lewalski, and Jon J. Hammill alleging that said Defendants were operating an illegal Ponzi scheme with more than 500 investors.
- 2. On April 1, 2010, this Court entered a Temporary Injunction restraining the activities of the Defendants and freezing Defendants' assets.
- 3. In addition, on April 1, 2010, this Court entered a Protective Order to protect from disclosure the identities of the investors in Botfly.
 - 4. Plaintiff anticipates filing motions for summary judgment and supporting

evidence in the near future. Plaintiff anticipates that some of the supporting documents, including affidavits, will contain information disclosing investors' identities.

- 5. Accordingly, Plaintiff requests that this Court enter an Order directing the Clerk of Court to file under seal certain documents designated by Plaintiff in order to protect the identities of the Botfly investors.
- Plaintiff will make available the evidence supporting the summary judgment 6. motions to the parties in this action in an unredacted format.
 - 7. No party will be prejudiced by the relief requested herein.

WHEREFORE, Plaintiff, Office of the Attorney General, Department of Legal Affairs, State of Florida, prays this Court enter an Order directing the Clerk of Court to file under seal certain documents designated by the Plaintiff, and for such other and further relief that this Court deems just and proper.
